



## NEW POLICIES

### 1. ORIGINAL REGISTRATION CERTIFICATE AND TRANSFER

Unless seller is an established Triangle Sales customer...all original documents must accompany the entry form. Horse(s) will not be cataloged otherwise.

### 2. SELLER CONTACT INFORMATION

To assist buyers with any questions, seller contact information will be printed in the sale catalog.

Note: This feature is not intended for pre-selling horse(s). Do not enter the sale if you will be tempted to pre-sell.

### 3. DRAW SYSTEM FOR HIP NUMBERS

A random draw system will be used to assign hip numbers using the first letter of the second dam's name.

- Horses are sorted alphabetically by the first letter of the second dam's name. Grade horses are ordered by substituting their names for the second dam's name.
- A random alphabetical draw is held to determine the starting point (letter) for hip numbering.
- A random numerical draw follows to assign hip numbers to sale entries.

When multiple horses with the same owner are drawn back-to-back, horses may be moved forward or backward ten lots in the order. Hip numbers for special productions/dispersals within a sale is determined by or on behalf of the owner.

### 4. OPTIONAL VETERINARY HEALTH EVALUATION FOR LIMITED WARRANTIES & RADIOGRAPHS

#### LIMITED WARRANTIES AND RADIOGRAPHS:

Seller's veterinarian may examine the horse and complete the Triangle Sales 48 Hour Limited Warranty Checklist.

Seller's veterinarian may radiograph the horse and from those resulting images may complete the Triangle Sales Radiograph Evaluation by grading the horse's overall condition as:

- acceptable
- manageable
- guarded

Note: Limited Warranties and Radiograph Evaluation form should be submitted to the sale office. Radiographs remain in the seller's possession.

### 5. MANDATORY OFFICIAL VETERINARY WITHDRAWAL STATEMENT FOR MEDICALLY UNFIT OR DECEASED SALE HORSE

Seller's veterinarian must complete and submit the Triangle Sales Official Veterinary Statement.

### 6. DECEASED SALE HORSE

Such sale horse will be excused with no charge if seller's veterinarian completes and submits the Triangle Sales Official Veterinary Statement.

### 7. COGGINS TEST

A negative Coggins test dated within one year of the final sale session will be acceptable.

### 8. ORIGINAL REGISTRATION CERTIFICATE(S) FOR BUYERS

Buyers will be offered an option regarding transfer of original registration certificate(s):

- Triangle Sales will send to the appropriate association, along with the seller's completed transfer and current fee
- Triangle Sales will send directly to the buyer via USPS Priority Mail along with the seller's completed transfer and current fee

### 9. DEDUCTIONS FOR PURCHASES

Sellers who are established customers may deduct any purchases from sale proceeds.

### 10. SALE RESULTS

Final sale prices of all entries, without buyer names, will be posted on the Triangle Sales website.
